Introduction

Management Registry, Inc. & M.M.D., Inc. and affiliated entities, dba Malone Workforce Solutions and Allstaff (**"Company"** or **"We"**) respect your privacy and are committed to protecting it through our compliance with this policy.

This policy describes the types of information we may collect from you or that you may provide when you visit the website www.malonesolutins.com (our "**Website**") and our practices for collecting, using, maintaining, protecting, and disclosing that information.

This policy applies to information we collect:

- On this Website.
- In email, text, and other electronic messages between you and this Website.
- Through mobile and desktop applications you download from this Website, which provide dedicated non-browser-based interaction between you and this Website.

It does not apply to information collected by:

- Us offline or through any other means, including on any other website operated by Company or any third party including our affiliates and subsidiaries; or
- Any third party, including through any application or content (including advertising) that may link to or be accessible from or on the Website.

Children Under the Age of 16

Information We Collect About You and How We Collect It

We collect several types of information from and about users of our Website, including information:

Information You Provide to Us

The information we collect on or through our Website may include:

- Information that you provide by filling in forms on our Website. <u>Information We Collect Through Automatic Data Collection Technologies</u>

As you navigate through and interact with our Website, we may use automatic data collection technologies to collect certain information about your equipment, browsing actions, and patterns, including:

- Details of your visits to our Website, including traffic data, location data, logs, and other communication data and the resources that you access and use on the Website.
- Information about your computer and internet connection, including your IP address, operating system, and browser type.
